FROM THE CHURCH COUNCIL

On Sunday, September 26th at 11:30AM there is a specially called meeting of the congregation to discuss, and potentially approve, two significant changes to our life together. The first is to build an Outdoor Ministry Center behind our parking lot. The second is to update our constitution.

An Outdoor Chapel (with storage)

Several years ago, we began conversations with our Boy Scout Troop to collaborate and construct a building that would provide storage and an outdoor gathering space. At first, the coronavirus pandemic put those conversations on hold. As the pandemic carried on, however, those conversations were picked up with enthusiasm as it became clear what a blessing a well-constructed, handicap accessible outdoor gathering space could be.

The church council has unanimously recommended for your approval the building of an Outdoor Ministry Center that will feature two garages for storage (one for the Boy Scouts and one for the church) connected by a 50' by 30' pavilion that will serve as an outdoor chapel, meeting area, and gathering place. The cost of this building is approximately \$200,000-250,000. If approved, the church would take out a loan (through the Mission Investment Fund – our denomination's bank) to begin construction with the intention of retiring the loan as soon as possible through charitable gifts from our church members and boy scout families. On Sunday, September 12th at 9:30AM there will be a question-and-answer session with the architect and planning committee. All interested and inquisitive parties are encouraged to attend. Additionally, drawings and the architect's renderings are available upon request. Finally, any concerns or questions will be addressed promptly by the chairman of the ad hoc Outdoor Ministry Center committee, Jim Pankow. A Constitutional Change

For the better part of a decade, we have flirted with the idea of updating our constitution. Currently, our constitution is out-of-date and inconsistent with the "model constitution" provided by our denomination, the ELCA. Moreover, various pragmatic items in our constitution are seemingly out-of-date and not well-suited for our congregation's ministry today. Apart from minor updates, the major changes our church council suggests are: 1. changing the congregational year from June - May to December - November, 2. moving our annual meeting to the first Sunday in December, and 3. reducing our council size from 15 to 9 members.

Our current congregational year runs from June to May. The congregational council proposes that we change the congregational year to December through November. This will better sync our congregational life with the church calendar and fiscal year.

Making this change will necessitate a change in scheduling our annual meeting. Currently, we meet on the last Sunday in January for our annual Budget meeting and again on the last Sunday in April for our annual Congregational Meeting. The church council now proposes that we meet once a year in December to adopt a budget for the upcoming fiscal year and report on the ministry of the congregation over the past year.

By reducing the size of the council from 15 to 9 members, we hope to create a leadership board that is representative of the congregation, able to provide oversight of operations, and provide visionary leadership and long-range planning. In addition to not burning out our volunteers by asking them to serve repeatedly as long-term board members, we hope to create a council that is energized to discuss the big-picture aspect of being church. Finally, having more council members than Jesus chose as Apostles seems unnecessary.

On Sunday, September 19th at 9:30AM there will be a question-and-answer session with members of the council and ad hoc constitutional committee regarding the proposed changes. Additionally, the modified constitution will be distributed and available from the church office for all interested and inquisitive parties. They say the best time to plant a tree is twenty-years-ago and the second-best time is today. In the same way, we might say the best time to build an outdoor ministry center would have been two-years-ago and the second-best time... today. Similarly, the best time to update our constitution might have been 10-years-ago, with the second-best time being... today.

We hope you will take time to look carefully at the proposed projects, ask questions, and get involved. As we emerge from this pandemic, we are optimistic about our future and excited about taking steps **today** that will leave our congregation better off **tomorrow**.

Potential Constitution Updates

PROPOSED BY-LAWS

(changes in italics)

I. CONGREGATIONAL MEETING

C10.01.01. The Annual Congregational Meeting shall:

- a. Be held at the beginning of the Congregational year in the month of December at a time and place determined by the Congregational Council;
- b. Include the election of members to the Congregational Council;
- c. Receive reports and proposed programs from the officers, committees, and organizations of the Congregation. The reports will be in writing. The Congregational Council may designate reports to be read at the meeting.
- d. Adopt the budget for the next fiscal year.

II. THE CHURCH COUNCIL

- C12.01.01 The Congregational Council shall consist of the pastor and nine (9) duly elected voting members.
- C12.01.02 Nominees for the Congregational Council shall be selected by the Nominating Committee.
- C12.01.03 Additional nominations may be made from the floor at the Annual Congregational Meeting, provided the nominee is a voting member in good standing and is present at the meeting to indicate his or her willingness to serve if elected.

III. CONGREGATIONAL YEAR

C12.02.01 The Congregational year shall run from December through November of the following year and:

- a. The officers shall be elected by the Congregational Council at the first meeting of the new Congregational year.
- b. The committees shall be appointed by the Congregational Council in January of the new congregational year.
- C12.02.02 The fiscal year of the Congregation shall be on a calendar year basis.



COUNCIL UPDATE

The August Church Council meeting began with devotions and a prayer for all those affected by the crisis in Afghanistan. After the minutes and agenda were approved, Pastor gave his report. Pastor reported on pastoral acts (including baptisms and memorials). Looking ahead many of our normal activities will resume in September including two worship services, Sunday School, confirmation, and various music ministries. If you desire pastoral care please contact Pastor Scott to arrange a visit or appointment.

The committees offered the following reports...

<u>Social Ministry</u> – The Creative Ministry team has purchased a sewing machine. They plan to create backpacks for suburban schools. St. John has resumed serving and providing meat monthly at Friends of Night People.

<u>Fellowship</u> – Our picnics in the park have been well attended. The Buffalo History boat tour has roughly two dozen attendees.

<u>Christian Education</u> – Registration is open for Sunday School and Confirmation. The registration forms can be found on the website on the "Youth Ministry" page.

<u>Worship and Music</u> – We will resume 2 services on September 12. A choir and a bell choir will be formed and each will accompany worship 4 times a year.

<u>Personnel</u> – Sara Accardi received a review from Pastor Scott. Her strong points were encouraged and guidance was provided to help her grow into her position as the Administrative Assistant.

<u>Building and Grounds</u> – Our water heater needs repair and a new dishwasher is needed. A motion was passed to spend \$3,000 to 5,000 for a new commercial-grade dishwasher.

<u>Stewardship</u> – The annual campaign will be held in October and will be accompanied by some sort of Mission Fair. A motion was passed to donate \$3,000 to ELCA Disaster Relief to assist with Western US wildfires and Haiti earthquake.

<u>Mutual Ministry</u> – The committee met in June to discuss concerns about communication between congregation members and Pastor Hannon about pastoral care needs. Actions were taken to improve communication, especially during pandemic restrictions.


<u>Permanent Endowment</u> – We currently have \$553,000 in the fund.

<u>Cemetery</u> – A car crash destroyed the St. John sign. Recovery is being sought from driver's insurance. Finance – Our second PPP loan was forgiven. 8-10 counters are now needed. They will begin to count on September 12. July income was strong. The financial situation of the church is strong.

In the new business portion of the meeting, the Outdoor Ministry Center and Constitutional Revisions were discussed. A motion was passed to call a congregational meeting on Sunday, September 26 at 11:30 AM to discuss and approve building the ministry center and adopt the constitutional revisions. Drawings and financial details regarding the ministry center will be emailed out to the congregation. Also, constitutional revisions will be emailed out to the congregation prior to the September meeting.

The meeting adjourned at 8:30 PM
